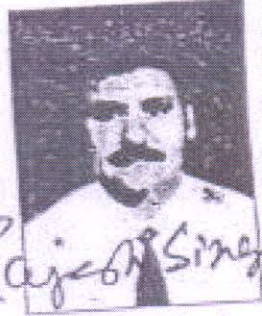
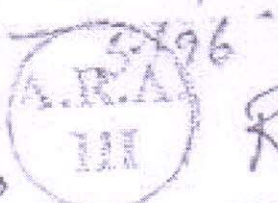

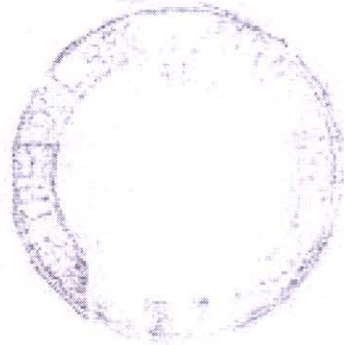

AND WHEREAS the Settler is also desirous to establish educational institute for general study and for technical and vocational training and particularly well organized school under CBSE, CISCE, West Bengal Board & other recognized board and even with collaboration with D.P.S. & other well established institute of Domestic & International repute and the Settler is also desirous to work in social welfare and in establishing hospitals, research institute and general development of socio-economic field including psychology and philosophical arena and to serve people for preservation of human culture and work for the benefit of humanity and mankind.

AND WHEREAS in order to materialize the idea of the Settler as aforesaid, the Settler has made over the sum of Rs.5,00,000/- (Rupees Five Lakh only) as specified in Schedule 'A' hereunder written to the Trustees by way of initial contribution at the present

which receipts the trustees herewith admit and acknowledge as per memo of consideration appearing hereunder written. However, the Settler has further agreed to provide all sorts of help to the trustees for establishing institutes as desired and in running the Trust smoothly depending upon necessity.

AND WHEREAS the Trustees have agreed to become Trustees and to hold and apply the said sum of Rs.5,00,000/- (Rupees Five Lakh only) and to give contributions, subscriptions and donations for the said fund and for such purposes and subject to the Trustees' powers and provisions contained in this Deed.

NOW THIS INDENTURE WITNESSETH that in pursuance of the aforesaid desire and for carrying out such desire into effect the Settler does hereby grant, transfer and assign unto the said Trustees the said property specified in Schedule 'A' hereunder written:-

1. The Trustees shall stand possessed of the said property specified in Schedule 'A' hereunder written and the profits and income thereof and the stock, fund, securities, donations, contributions, subscriptions and amalgamations that may hereafter be collected by the Trustees under these presents and the properties movable and immovable for the time being representing the same respectively (hereinafter for brevity's sake called "the Trust Funds") upon the Trust and with and subject to the powers, provisions, agreements and declarations hereinafter declared and contained of and concerning the same, that is to say,

a) Upon Trust in the first instance to collect the dividends, interests, rents, profits and other income of the Trust Funds (hereinafter for brevity's sake called "the Income of the Trust Funds") and from and out of the same in the first place pay all the proper costs, charges and expenses of the Trust Funds and incidental to the collection thereof and all outgoings payable in respect of the Trust Funds and any immovable property or properties for the time being subject to the trusts hereof as also the costs, charges and



expenses of and incidental to the execution, management and administration of the trusts and powers herein contained.

b) Subject to the provisions of sub-clause (a) of this clause, the Trustees shall hold the Trust Funds upon trust (so that as far as practicable that corpus shall always remain intact and only the income thereof shall be used, but with liberty to the Trustees at their discretion to use the corpus from time to time either wholly or in part or parts) for the purposes specified in this trust including : for

- i) Relief to the poor/deserving persons;
- ii) Advancement of education; establishment of good schools, colleges & other institute;
- iii) Medical relief;
- iv) Advancement of any other object of general public utility as the Trustees may think fit and for one or more of such purposes to the exclusion of other or others as the Trustees may think fit provided that the income as well as the capital as well as the corpus shall be applied only towards the purposes as aforesaid and any accumulation of income shall also be made and deemed to be made for application to such purposes as aforesaid PROVIDED FURTHER:

a) That notwithstanding anything hereinbefore or hereinafter contained, the income as also the corpus of the Trust Funds shall be applied and be applicable only to or for such purposes and objects and subject to such conditions or limitations if any as may from time to time be laid down in the Income-Tax Act, 1961, or any other Act governing the taxation of income as will ensure or make the Trust hereby established and its income as eligible for exemption from taxation under the Income Tax Act, 1961, or any replacement or re-enactment thereof or modification thereof or under any other Government taxation for the time being in force in India.

b) And further so that the Trust hereby established shall be one to which the provisions of Section 80G of the Income Tax Act, 1961, or any replacement re-enactment or the modification thereof for the time being in force shall apply so that any donation thereto be recognized eligible for exemption or relief from tax in regard to the Donor.

c) Without prejudice to the generality of the foregoing objects or purposes but subject as aforesaid IT IS DECLARED that the Trustees shall in each year apply the income of the Trust Funds and may at the discretion at any time and from time to time apply also the Trust Funds or any part or parts of the Trust Funds in or towards any one or more of the following objects or purposes to the exclusion of the other or others of them in such proportion and manner in all respects without distinction or irrespective of religion, caste or creed as the Trustees may in their absolute discretion think proper, that is to say:

(1) To establish, erect, equip and maintain or contribute towards establishments, erection, equipment and maintenance of colleges, schools, bal-mandirs, swimming pools, hospitals, dispensaries, medical clinics - including clinics for tuberculosis patients, nursing homes, maternity homes, orphanages, home for widows, destitute or other unattached woman, vikas grahas and institutions for the relief of poor, education, medical relief and advancement of other object of general public utility.

(2) For the purposes aforesaid to found, maintain, organize, run, manage, supervise, superintend, affiliate, control, guide and aid Pathshalas, Schools, Colleges, Universities, Hospitals and other academic institutions including Boarding Houses, Museums, laboratories, libraries, exhibitions, lecture halls, practical classes and other educational institute and also Hospitals, Research

(8) To give aid to institute, working for doing welfare and other development of humanity and mankind.

(9) Educational institutions of all levels standard and course encouraging literature, arts, medicine, science, agricultural crafts, history, technology, agricultural technology and technical education in all branches.

(10) Endowments to different universities existing or which may hereafter come into existence for the purpose of encouraging education.

(11) Endowments to hospitals, infirmaries, maternity homes, orphanages, sanitariums, boarding houses, hostels and charitable dispensaries.

(12) To propagate to do all deeds and things to develop and encourage and to preach brotherhood, human culture and sense of responsibility, to advance, promote and increase commercial, technical, agricultural, industrial and other kinds of education amongst the people in general irrespective of class, creed, sex, religion, nationality and place in or outside India as the Trustees may think fit.

(13) To grant stipends, scholarships, studentship and other allowances, concession and gratuities to deserving students and candidates and other needy persons and also to award scholarships and fellowships in cash or in such other form on such terms and conditions as the Trustees may think fit for the purpose of undertaking, prosecuting and encouraging studies PROVIDED THAT such scholarships and fellowships shall be awarded to such poor and/or deserving students and scholars studying in schools, colleges, universities and other educational institutions in India or abroad and who cannot afford and have no means to prosecute the same.
